SHIPPING YOUR PUPPY:

Shipping arrangements can be made for your puppy. Shipping charges and all associated fees are charged to the buyer and are due before shipping can occur. The shipping fees associated with your puppy will be listed in the Puppy Sales Contract. Your assigned puppy will be shipped starting at 8 weeks of age. If puppy is being shipped, buyer understands that both puppy and all costs involved in shipping must be paid for by 6 weeks of age. Puppy sales contract and Health Guarantee must be signed by buyer and returned before puppy can be shipped.

FIRST RIGHT OF RECOVERY:

If the buyer is unable to care for or chooses to change his/her mind about caring for the puppy purchased Springer Hills Farm retains the right for recovery of the puppy at the buyers' expense. The buyer must notify Springer Hills Farm as to the change in circumstance and give the seller first right to the dog before any other action is taken.

This includes and is not limited to selling the dog to another buyer. The original purchase price of the dog is non-refundable if there is nothing wrong with the puppy/dog and the buyer is just unwilling or unable to care for the animal. To protect both the dog and the kennel's reputation we have included this clause. We do not want our puppies sold to a puppy mill, or turning up in a pound, humane society, pet shop, or auction.

FAMILY PET PRICING

All puppies are sold <u>Family Pet Pricing</u> unless contracted otherwise. All puppies sold on Family Pet Pricing will be required to be Spayed / Neutered by 9 Months of age <u>No Exceptions</u>, unless contracted otherwise (Permission given from Springer Hills Farm.) Buyer Understands if puppy is not spayed / Neutered By 9 Months of age Buyer is subject to a **500.00 Dollar fine** and Given a Warning. If Above issue is not corrected within 1 months' time, Springer Hills Farm has the right to remove puppy.
